Directions to WSLH - Environmental Health Division Lab at 2601 Agriculture Drive:

We are located on Madison's southeast side - just northwest of the intersection of Interstate Hwy. 90 and U.S. Hwys. 12 & 18. From Hwys. 12 & 18 (the south "Beltline"), take U.S. Hwy. 51 (Stoughton Road) north about one mile. Turn right (east) onto Pflaum Road. Proceed about one mile on Pflaum Road, and then veer right onto Agriculture Drive. Our building is on the hillside on the left. Customer parking is available near the entrance. Our Customer Service Department is just inside the entrance.
